- **Secure Email Enhancement:** Reminder--we upgraded to a secure email system several months ago. It allows more of our messages to reach your email box. The new system reduces the number of secured messages by 95%, providing easier message access for you. If you haven't used it yet, you'll be prompted to set up credentials the first time you access the upgraded secure email system.
- **Website:** On March 31, 2021, our website will change from [goldleafpartners.com](http://goldleafpartners.com) to a transition webpage branded FuturePlan and providing our contact information and a link to resources and login portals.
- **Cycle 3 Restatements:** Clients requiring a Cycle 3 restatement will receive further communication from us in the spring.
